## **DRILLING UPDATE**

Desert Energy Limited is pleased to announce that aircore drilling has commenced at its Downs East property located 60km from Yeerlirre in the northeast Yilgarn region of Western Australia. Progress has slow and interrupted by rig breakdowns.

Two lines have been drilled across a small part of the eastern radiometric-soil anomaly. Calcrete has been observed on one line. The holes are expected to be logged shortly.

The drill rig is moving towards the high grade uranium surface sample discovery area (grades up to  $0.3\%U_3O_8$ ) where calcrete outcrops through the sand cover. The host calcrete is known to continue westwards from the discovery area over a strike length of 4.5km and is up to 500m wide. The drill rig is expected to commence on this area early next week.

Samples will be sent to Perth for assay at the completion of the first phase of drilling which is expected to take another four weeks.

## **Old Station West**

Desert Energy's Old Station West project is located about 150km southwest of Yeerlirrie in a geological setting similar to Downs East.

The target is calcrete associated with a pronounced 15km uranium channel radiometric anomaly.

Drill permitting is proceeding and the Company expects approvals to be granted within the next month.
